### 1 Introduction

The CT Viewer<sup>TM</sup> 2 computer software allows users of the MOHR CT100B Time-Domain Reflectometer (TDR) to transfer, view, and manipulate the cable scans that have been saved on their instruments. This software package allows the user to select stored scans and view, compare, and do a variety of mathematical transformations to any of the traces.

CT Viewer 2 also allows the user to create reports and print plots that can be imported into word-processing or report creation software, to create files of traces suitable for transfer to others, and to load trace files created by others.

### 1.1 Compatibility With the MOHR CT100 TDR

CT Viewer 2 is fully compatible with the older MOHR CT100, including connecting, transferring traces, and remote control. Some instructions in this manual refer to menus on the CT100B. Because the CT100B menu system differs from the CT100, these instructions may not apply to the CT100.

## 2 Installation and Setup

Installation requirements:

- 1. Windows Vista or newer
- 2. Microsoft .NET Framework 4.6 (included on the installation DVD)

### 2.1 Installing CT Viewer™ 2

Insert the CT Viewer 2 DVD into your DVD drive.



Figure 2.1 CT Viewer 2 installer package.

If auto-run is enabled, CT Viewer 2 will automatically launch the installer package (Figure 2.1). If auto-run is disabled, the CT Viewer 2 installer package can be executed manually by clicking on DVD-DRIVE\setup.exe (where DVD-DRIVE is the drive letter of the DVD drive).

Although the installer package suggests installing SQL Server 2012 Express before installing CT Viewer 2, the SQL Server software is optional. It only needs to be installed if you previously used CT Viewer 1 and would like to access databases you created while using that program. See Section 2.2 for more information on installing the SQL Server software.

On the launcher, use the drop-down menu next to *Operating System Type* to select either 64-bit or 32-bit, depending on what type of operating system the PC has.

Click on Install CT Viewer Software to begin installation.

The installer will try to install the USB drivers for the CT100B. Most computers will show a prompt to approve the driver installation. If the driver installation is cancelled, CT Viewer 2 will not be able to connect to the CT100B over USB.

The USB drivers can be installed any time after the installation. See Section 2.3.

After CT Viewer 2 is installed, you can install any optional components included on the DVD. See Section 2.2.

The installer will place a shortcut to CT Viewer 2 on the desktop. Double-click on the icon to get started. The icon should look similar to Figure 2.2.



Figure 2.2 CT Viewer 2 icon.

### 2.2 Installing Optional Components

By default, CT Viewer 2 will use any hardware video acceleration that is installed on the system. For convenience, Microsoft DirectX 9.0c has been included on the installation DVD. If you wish to install DirectX, click on  $Install\ DirectX\ 9.0c$  in the launcher window and follow the prompts.

If you wish to install SQL Server 2012 Express software for database access, click on *Install SQL Server 2012 Express*. Follow the prompts and choose the default values. If the SQL Server software successfully installs, you should be able to create databases to store traces in CT Viewer 2.

For administrators who want extra control over their SQL server install, SQL Management Studio has been included on the installation DVD. Click on  $Install\ SQL\ Management\ Studio$  to install this software.

### 2.3 Installing USB Drivers

USB drivers are typically installed automatically during CT Viewer 2 installation (Section 2.1). The drivers can also be installed at any time using the following procedure.

Connect the CT100B to the computer by means of a standard A-B USB cable. Plug the B (square) end of the cable into the back of the CT100B, and the A (rectangle) end of the cable into a USB port on the PC. (The USB ports on the front of the CT100B are used for thumb drives, keyboards, etc., not for connecting to your PC.)

Power on the CT100B and allow it to boot up completely.

Windows will detect that a new device is connected to the computer (Figure 2.3).



**Figure 2.3** After connecting the instrument via USB, Windows will suggest installing driver software for the CT100B.

Note: A common problem with Windows is that it may be configured to not display the window shown in Figure 2.3. If this happens, run the *Device Manager* software in Windows. The CT100B will show up in the device manager window as a device with a question mark or exclamation point. The symbol means that the driver is not yet installed. Right-click on the CT100B and select *Update Driver* to continue with the driver installation.


Choose Locate and Install Driver Software to advance to the next step. At this time, insert the CT Viewer 2 DVD into the DVD drive.

After inserting the CT Viewer 2 DVD and clicking the *Next* button, Windows will search the DVD for the necessary files. After a successful search, Windows will prompt the operator to install the driver. See Figure 2.4. To proceed to the next step, click on *Install*.

To confirm the install, the final display should look similar to the one pictured in Figure 2.5.

#### 2.4 Updating CT Viewer

You should always be using the latest version of CT Viewer 2. If the computer running CT Viewer 2 is connected to the Internet, it may automatically check for updates when you start CT Viewer 2. You can also click on *Help* then *Check for Updates* to see if you are running the latest version.

If CT Viewer 2 finds that there is a newer version of the software available, it will launch an update window (Figure 2.6). This window lists the updates made to CT Viewer 2.



Figure 2.6 When CT Viewer 2 can be updated, it will launch an update window.

Click on *Install Update*. CT Viewer 2 will download the update. Then click *Install and Relaunch* and follow the prompts. You will now be using the latest version of CT Viewer 2.

If the computer running CT Viewer 2 cannot connect to the Internet, and you would like to install the most recent version of CT Viewer 2, contact MOHR for an installation DVD.

### 3 Connecting to the CT100B

### 3.1 Connecting the CT100B to CT Viewer 2 via USB

USB drivers are usually automatically installed with CT Viewer 2. But they can be installed at any time using the steps in Section 2.3. If USB drivers are installed, connecting the CT100B to CT Viewer 2 via USB is a quick process.

Double-click on the CT Viewer 2 icon on the computer desktop to get started. Connect the CT100B to the computer using a standard A-B USB cable. Plug the B (square-shaped) end of the cable into the back of the CT100B, and the A (rectangle-shaped) end into the PC. This can be done before or after you turn on the CT100B.






Figure 3.1 The Find Tester command appears as on on-screen button and in the File menu.

Before the USB cable is plugged in, CT Viewer 2 will have a button saying *Find Tester* (Figure 3.1). *Find Tester* should automatically change to *Open Tester* once the USB cable is plugged in and the CT100B is turned on (Figure 3.2).

If it doesn't change, click on *Find Tester* and CT Viewer 2 will connect to the CT100B and bring up a transfer dialog window listing the collection of traces on the CT100B (Figure 3.3). In the transfer dialog window common commands are available via buttons (Table 3.1).



**Figure 3.3** Transfer dialog window showing traces stored on the CT100B. The trace named "screen" is selected.

Table 3.1 Commands in the transfer dialog window

Button	Command
Transfer To	Copy the selected traces to the computer. See Section 3.5 for more details.
Select All	Select the entire collection of traces available on the CT100B.
Delete	Delete the selected traces from the CT100B. This removes them permanently. This option can take some time.

### 3.2 Connecting the CT100B to CT Viewer 2 via Ethernet

An alternative approach is to connect the CT100B to the computer by means of an Ethernet cable. This allows long distance control and transfer of files.

Plug an Ethernet cable into the back panel of the CT100B and connect the cable to the network. Allow the CT100B to boot up completely. Double-click on the CT Viewer 2 icon on the desktop of your PC.

You can use either CT Viewer 2 or the CT100B to connect to each other via Ethernet. There are different steps for each connection.

### 3.2.1 Using CT Viewer 2 to Connect to the CT100B




Figure 3.4 The Find Tester dialog box.




Figure 3.5 The CT100B's IP address.

In CT Viewer 2 click on the *Find Tester* button. This will bring up a dialog box listing a potential CT100B connection and a spot where you can manually enter an IP for the CT100B (Figure 3.4). To find the CT100B's IP address, press the blue *MENU* button, then *Settings*, then *Network Settings*, then *Show IP Config* (Figure 3.5). In CT Viewer 2, either choose *OK* under the potential connection or type in the IP address and click *Use Manual Entry*.

If you have successfully connected to the CT100B, the *Find Tester* button should have changed to *Open Tester* and CT Viewer 2 will display a message that a CT100B has connected to it with the IP address of the CT100B (Figure 3.6).



**Figure 3.6** The message displayed by CT Viewer 2 when a CT100B connects.

You can now open the tester in CT Viewer 2 using the  $Open\ Tester$  button or  $File \to Open\ Tester$ . See Table 3.1 for an explanation of the commands available when you use  $Open\ Tester$ . You can also start a Remote Control session. See Section 6 for more information about Remote Control.

#### 3.2.2 Using the CT100B to Connect to CT Viewer 2





Figure 3.7 The Main menu of the CT100B.

Press the blue MENU button on the CT100B to open the Main menu. See Figure 3.7.

Select Connect to CT Viewer on the CT100B. A menu with connection options appears along the bottom of the CT100B's screen (Figure 3.8).



**Figure 3.8** The CT Viewer connection menu on the CT100B.

Select  $Find\ CT\ Viewer$  on the CT100B, and the CT100B will scan for servers and will either automatically connect to a server if there is only one available or bring up a list of detected servers to choose from.

Use the *M-FUNCTION* knob to choose a PC, and press the *Select* button. If the PC you wish to connect to is not in the list, choose *Cancel* to go back to the previous screen so that you can manually connect to CT Viewer 2.

If you select *Manual Connect*, the *Select PC* dialog box will appear (Figure 3.9).

Use the M-FUNCTION knob to choose a PC and press the Select button. If the PC you wish to connect to is not in the list, choose  $Add\ PC$  to add it.





Figure 3.10 Using CT Viewer 2 to find the IP address of the PC.

To find the address of the PC running CT Viewer 2, go to  $File \rightarrow Ethernet$  Configuration in CT Viewer 2 (Figure 3.10). A window will appear that will list the address or addresses of that PC. Enter that information into the Add PC dialog box on the CT100B (Figure 3.11).

CT Viewer 2 will display a message that a CT100B has connected to it. You can now open the tester ( $File \rightarrow Open\ Tester$ ) or start a Remote Control session.

#### 3.3 Installing a CT100B License File

Depending on how it was purchased, the CT100B may be supplied with either a 30-day demonstration license or permanent license. Current license information can be found on the CT100B by navigating to  $Settings \rightarrow Info \rightarrow License \rightarrow License Info$ .

If the CT100B came with a permanent license already installed, no new license installation is necessary. If your CT100B has a license with a pending expiration and you are unsure how to upgrade to a permanent license, contact MOHR. MOHR will email you a permanent license file. Save the license file to your computer before attempting to install it on the CT100B.

Connect the CT100B to the computer by means of a USB or Ethernet cable. Power on the CT100B and allow it to boot up completely.

Connect the CT100B to CT Viewer 2. For assistance, see Section 3.1 and Section 3.2.

Once a successful connection has been made, click on Help, then  $Install\ License$ .

Browse to the location of the saved license file and select it. The CT100B will display a message if the license file was installed successfully.

#### 3.4 Updating the CT100B

Connect the CT100B to the computer by means of a USB or Ethernet cable. Power on the CT100B and allow it to boot up completely.

In CT Viewer 2, click on File then Open Tester (Hotkey: Ctrl-F).

The transfer dialog window will appear and list the collection of traces on the  $\rm CT100B$ .




Figure 3.12 CT Viewer 2 has detected that there is an update available for the CT100B.

If there is an update available, CT Viewer 2 will prompt the operator to update the CT100B (Figure 3.12). Generally, you should always be running the latest versions of CT100B and CT Viewer software. See Section 2.4 for information about updating CT Viewer 2 software.

The update process of the CT100B is tracked via a progress bar. CT Viewer 2 will prompt the operator when the update is complete. The operator should reboot the CT100B and reconnect it with CT Viewer 2 after the reboot.

### 3.5 Copying Traces From a CT100B to the Computer

- Connect the CT100B to the computer by means of a USB or Ethernet cable. Power on the CT100B and allow it to boot up completely.
   Note: If the CT100B is connected by an Ethernet cable, refer to Section 3.2 for instructions on how to connect CT Viewer 2 to the CT100B over Ethernet.
- 2. In CT Viewer 2, go to the *File* menu and choose *Select Default Trace Folder*. Select or create a folder to store your trace files.
- 3. In CT Viewer 2, click *Open Tester* (Hotkey: Ctrl-F). A transfer dialog window will appear and list the collection of traces available on the CT100B.
- 4. Select the desired traces. To select multiple traces, either hold down Ctrl while selecting each trace or hold down Shift to select neighboring traces.




Figure 3.13 The Transfer To dialog box for copying traces to a computer.

- Click on the Transfer To button. A dialog box should appear (Figure 3.13).

- 6. Verify that the checkbox next to Send Traces to Database is not checked.
- 7. Verify that the destination folder is correct and then click Start Transfer.




Figure 3.14 A trace copied from the CT100B.

Once the selected traces are copied from the CT100B, they will load onto the CT Viewer 2 screen. CT Viewer 2 scales loaded traces to fit vertically, covering at least five divisions (Figure 3.14).

### 3.6 Copying Traces From a CT100B to a Database

Using a database to store your traces is optional. It is only recommended for users who previously used CT Viewer 1, stored traces in a database, and who would like to still be able to access those traces. Only simple saved traces can be transferred to a database. If other trace types, such as derivative or difference traces, need to be transferred from the CT100B to CT Viewer 2, see Section 3.5. See Section 8 for information on configuring a database.

- Connect the CT100B to the computer by means of a USB or Ethernet cable. Power on the CT100B and allow it to boot completely.
   Note: If the CT100B is connected by an Ethernet cable, refer to Section 3.2 for instructions on how to connect CT Viewer 2 to the CT100B over Ethernet.
- 2. Click on Open Tester (Ctrl-F).
- 3. A transfer dialog window will list the collection of traces available on the CT100B
- 4. Select the desired trace on the list. To select multiple traces, either hold down Ctrl while selecting each trace or hold down Shift to select neighboring traces.
- 5. Click on the Transfer To button.




Figure 3.15 The Transfer To dialog box for copying traces to a database.

- 6. Make sure the box next to *Send Traces to Database* is checked (Figure 3.15).

- Verify the SQL server and database are correct; otherwise, change the SQL server and database using the drop-down menus.
- 8. Once a SQL server and database have been selected, an operator can start the transfer process by clicking on the  $Start\ Transfer$  button.

# 4 User Interface and On-Screen Menus

#### 4.1 User Interface Overview




Figure 4.1 A sample workspace with three traces. The numbers on the figure correspond with the numbers below.

In Figure 4.1, we can see a sample workspace with three traces loaded.

- 1. The ruler at the top is drawn using the units defined by the user. Figure 4.1 displays the horizontal units in meters.
- 2. On-screen menu buttons are available for quick access to common commands.
- Names of current loaded traces are displayed. The currently selected trace is drawn in red and the label is also red and in a slightly larger font than the other traces.
- 4. The current scaling information for the selected trace is shown at the bottom left of the display.
- 5. The velocity of the pulse and the name of the currently selected trace are displayed at the bottom center of the window.
- 6. The *Information Box/Cursor Measurements* window at the bottom right shows the X-value (distance) in meters (or current horizontal units) and nanoseconds, and Y-value in millirho and ohms at each cursor.

#### 4.2 Tabs




Figure 4.2 Multiple open workspace tabs.

CT Viewer 2 has workspace tabs (Figure 4.2). These allow for the user to have multiple independent workspaces each with their own individually loaded traces

and history.

- 1. To create a new workspace tab, click on the yellow New Panel icon found to the right of the workspace tabs. This will add a new tab to CT Viewer 2 where a user can load additional traces.
- 2. To close a workspace tab, click the X icon on the workspace tab. **Note:** It is not possible to recover a tab once it has been closed.

## 4.3 On-Screen Buttons and Tools Menus

The following functions assume that the operator has loaded a few traces onto the CT Viewer 2 workspace. Use Figure 4.1 as a base figure image for the following sections. Functions of on-screen buttons (Figure 4.3) can also be accessed through the Tools menu.



Figure 4.3 On-screen buttons.




Figure 4.4 From left, the Tools menu, the Tool drop-down menu, and the Tools floating window.

There is a *Tool* drop-down menu that can be used to access some of these commands, as well as a "floating" window that contains a list of commands. See Figure 4.4.

#### 4.3.1 Reset X




Figure 4.5 The selected cable has been moved 0.55 meters right from its original position.

Selecting  $Reset\ X$  ( $Reset\ X$  Offset in the Tools menu) will restore the X-offset for the selected trace to zero. Figure 4.5 shows the selected trace has been shifted to the right 0.55 meters. The offset is displayed next to the trace label. The  $Reset\ X$  button will put it back to the 0 offset position as shown in Figure 4.1.

#### 4.3.2 Reset Y




Figure 4.6 The selected trace has been moved upward from its original Y-offset

Selecting Reset Y (Reset Y Offset in the Tools menu) will reset any relative changes done on the Y-axis (millirho) of the selected trace to zero. Figure 4.6

shows that the selected trace has been moved up on the display. Reset Y will restore it to its original position as shown in Figure 4.1.

## 4.3.3 Adjust X, Y Offsets




Figure 4.7 The Adjust X, Y Offsets dialog box.

The Adjust X, Y Offsets menu selection allows the user to set specific X and/or Y offsets or ohms at cursor for the selected trace (Figure 4.7). Changing the Y offset affects ohms at cursor and vice versa.

#### 4.3.4 Vert Re-Center at Cursor Location

The Vert Re-Center at Cursor Location menu selection moves the trace vertically so that the cursor/trace intersection is centered.

#### 4.3.5 Find Cursor

Clicking the *Find Cursor* button will swap the active and inactive cursors. If the newly active cursor is off-screen, the view will be re-centered on that location. Use *Find Cursor* repeatedly to jump back and forth between two locations.

#### 4.3.6 Set Cursor

Clicking Set Cursor gives you a dialog box to enter specific X-ruler coordinates for the two cursors (Figure 4.8).



Figure 4.8 The Set Cursor dialog box.

#### 4.3.7 Reset Cursor

Clicking Reset Cursor will move cursors into the view region if they are off-screen.

#### 4.3.8 Fit Trace




Figure 4.9 The view region is zoomed in so only part of the selected trace is visible.




Figure 4.10 Window after Fit Trace was executed.

The Fit Trace button automatically changes the offset and X- and Y-scales so that the selected trace will fit in the entire workspace. It is most useful to restore an overview of a trace after zooming in to look at details. For example, Figure 4.9 shows a zoomed-in view. Clicking on Fit Trace will restore the horizontal and vertical scales so that the entire trace fits in the window again. Figure 4.10 shows the same traces after the Fit Trace command was used.

## 4.3.9 Fit Vertical, Vertical Fit Only

The on-screen button for this function is *Fit Vertical*. It is also found under the *Tools* window as *Vertical Fit Only*. Choose *Fit Vertical* to re-scale selected traces so that they fit vertically on the screen.

#### 4.3.10 Fit Cursors

Selecting Fit Cursors zooms in the window horizontally to display only the region between the cursors.

#### 4.3.11 Match V-Scale




Figure 4.11 The Match V-Scale command changes each selected trace's vertical scale to match the primary selected trace (red).

The  $Match\ V$ -Scale menu selection changes all selected traces' vertical scale to match the scale of the primary selected trace and lines them up. See Figure 4.11 for an example.

#### 4.3.12 Select

(Hotkey: Tab)

The Select button selects the next trace in the list. Repeatedly choosing Select will cycle through all of the visible traces.




Figure 4.12 Trace List sub-window.

Alternatively, click on a trace name in the *Trace List* sub-window, shown in Figure 4.12. Open the *Trace List* sub-window by selecting  $Window \rightarrow Traces$  from the menu bar.

#### 4.3.13 Select All

(Hotkey: Ctrl-A)




Figure 4.13 The Select All command selects every trace in the workspace.

The Select All button selects all traces visible on the display. The primary selected trace will be highlighted in red while secondary selected traces will be highlighted in teal (Figure 4.13).

If all traces are selected, the  $Deselect\ All$  button or menu item can be clicked to deselect all the traces. Or you can press the Escape key to deselect all traces (Figure 4.14).



Figure 4.14 Press the Escape key to deselect every trace.

## 4.3.14 Set Trace Color

Select any trace or traces, then choose Set Trace Color. A window for picking colors will appear (Figure 4.15). Use this window to change the color of the selected traces.



Figure 4.15 The window for selecting trace color.

## 4.3.15 Hide, Show All

The *Hide* button hides the selected traces from the display but keeps them in the workspace. Use *Show All* to redraw them on the screen. The *Visible* checkbox in the *Trace List* sub-window shows the visibility status of each trace (see Figure 4.12). Click on the check box to hide or show a trace.

#### 4.3.16 Remove

(Hotkey: Delete)

Clicking the *Remove* button removes the selected traces from the workspace. This will not delete them from permanent storage (either disk files or database).

#### 4.3.17 Pan

Found on all the Tool menus. When Pan is selected, clicking the background and dragging with the mouse will move traces, cursors, etc. This is the default tool for the mouse.

#### 4.3.18 Selection Box

Found on all the *Tool* menus. Choose *Selection Box*, then drag over a region of the screen. Traces inside the region will be selected.

#### 4.3.19 Zoom Box

Found on all the *Tool* menus. Choose *Zoom Box*, then drag over a region of the screen. CT Viewer 2 will zoom in on that region.

## 4.3.20 Set Vp




Figure 4.16 The field for setting the Vp.

The field for setting the Vp can be displayed by clicking on the  $\mathit{Vp}$  button (Figure 4.16).

Type a new Vp setting and click the *Set* button to set the Vp for the selected trace. The horizontal scale and cursors will be redrawn using the new value.

#### 4.4 Window Menu

CT Viewer 2 has several on-screen windows than can be turned on and off under the *Window* menu (Figure 4.17). Some of them, like the *Tools* window, can act as shortcuts to functions that are also found in the drop-down menus. Others provide additional functionality to CT Viewer 2. These windows are explained in the following sections.



Figure 4.17 The Window menu.

The *Tools, History, Traces*, and *Trace Minimap* windows can easily be moved anywhere within the CT Viewer 2 workspace or even outside the main CT Viewer 2 window by clicking and dragging them with the mouse.

The *Information Box* window is typically located in the bottom right of the screen, though it can be moved by clicking the red square at the bottom right of the box and then clicking and dragging with the mouse. Clicking the red square again will move the box back to the bottom right.

#### 4.4.1 Reset Windows Location

Clicking the Reset Windows Location button in the Window menu will reset visible on-screen windows to their default locations.

#### 4.4.2 Tools Window

The functionality of the *Tools* window can be found in Section 4.3.

## 4.4.3 History List Window




Figure 4.18 History List window.

The *History List* displays a list of all the actions performed in the current workspace (Figure 4.18). By clicking the undo and redo buttons at the bottom of the *History List*, the user can reverse or repeat actions. The user can also use Ctrl-Z and Ctrl-Y to reverse or repeat actions.

Left-clicking on any action in the  $History\ List$  will undo all actions up to that point.

#### 4.4.4 Trace List Window

The *Trace List* displays a list of all traces that are currently loaded into the active workspace, indicating if the trace is visible on-screen, the type of trace, and the trace's name. In addition, X and Y offsets for traces will be displayed if that option is selected in the *Trace Label* section of the *View* menu. The primary selected trace will be highlighted in red and any secondary selected traces will be highlighted in teal (Figure 4.19).



Figure 4.19 Trace List window.

The user can select traces within the *Trace List* by left-clicking on any individual trace or by clicking the up or down arrows at the bottom of the *Trace List*.

Holding down the Shift key and left-clicking on an unselected trace will select all the traces between the unselected trace and the primary selected trace.

Holding down the Ctrl key and left-clicking on a trace will select and unselect traces in addition to the primary trace.

By checking and unchecking the box in the visible column, the user can show or hide the associated trace in the workspace.

# 4.4.5 Information Box/Cursor Measurements Window

The Information Box window at the bottom right of the screen displays cursor measurements for the selected trace in the chosen horizontal and vertical units (Figure 4.20). Measurements for the active cursor are displayed in red with stars next to them. Other measurements in the box are for the inactive cursor as well as the relative distance, relative time, relative reflection coefficient, and relative impedance. The Information Box can also display standard deviation and voltage standing wave ratio (VSWR). See Section 5.11.5 and Section 5.11.6.

## 4.4.6 Trace Minimap Window




Figure 4.21 The Trace Minimap window shows a mini version of the entire selected trace and highlights the part of the trace visible on-screen.

The *Trace Minimap* shows a mini version of the entire selected trace. The part of the trace that is visible on-screen is highlighted in a teal box on the minimap (Figure 4.21).

## 4.4.7 Hide All Windows

By clicking the  $Hide\ All$  menu item in Window, the user can hide all of the on-screen windows except the  $Information\ Box/Cursor\ Measurement$  window. The  $Information\ Box$  can only be hidden by unchecking it in the Window menu.

## 5 General Functions

## 5.1 Manipulating Traces on the Workspace




Figure 5.1 A workspace with three traces displayed.

You can zoom in and out on traces, and move them left, right, up, and down to see details easier. This section describes the keystrokes necessary to do these things. See Figure 5.1 for an example of three loaded traces. For each of the following sections, use Figure 5.1 as a base image. Each of the following figures depicts the screen after some operation.

# 5.2 Changing the Viewpoint




Figure 5.2 Use the D key to shift the view region to the right, revealing area on the left that was previously hidden.




Figure 5.3 Use the S key to shift the view region down, revealing area on the top that was previously hidden.

To move all on-screen traces, use the W-A-S-D keys to move them up, left, down, and right respectively (Figure 5.2 and Figure 5.3).

Select traces by left-clicking on them. To select more than one trace, hold down the Shift key and click additional traces on the workspace.




Figure 5.4 Use Shift-S to move only the selected trace down relative to the other traces.

To move only the selected trace(s), use the same W-A-S-D keys while holding down Shift (Figure 5.4).

Alternatively, left-click and drag the mouse to move all on-screen traces in any direction. Hold down Shift and left-click and drag the mouse to move the selected trace up and down independently of other on-screen traces. Hold down Ctrl and left-click and drag the mouse to move the selected trace left and right independently of other on-screen traces. Or hold down Ctrl and Shift and left-click and drag the mouse to move the selected trace in any direction independently of other on-screen traces.

## 5.3 Changing the Vertical Scale

Select a trace by left-clicking on it. To select more than one trace, hold down the Shift key and click additional traces on the workspace.

To decrease the vertical scale (zoom in), either scroll the mouse wheel up or press the - key. To increase the vertical scale (zoom out), either scroll the mouse wheel down or press the + key.

# 5.4 Changing the Horizontal Scale

Any changes made to the horizontal scale affect all on-screen traces.

To decrease the horizontal scale (zoom in), press the Q key.




Figure 5.5 Increasing the horizontal scale (zooming out) using the E key.

To increase the horizontal scale (zoom out), press the E key. See Figure 5.5 for an example. As before, use Figure 5.1 as a base image for comparison.

The current X and Y scaling information is displayed at the bottom left of the workspace.

# 5.5 Printing a Screenshot

With CT Viewer 2 you can print a screenshot of the current workspace. To do this, click on *File* and then *Print* (Hotkey: Ctrl-P). A print dialog will appear where you can select the printer to use and adjust basic settings for printing.

Additionally, to print multiple loaded traces on separate pages, click on *File* and then *Print Individual Trace*. A print dialog will appear that is used for all of the selected traces.

## 5.6 Exporting a Screenshot




Figure 5.6 Save As dialog to save a screenshot.

Click on *File* then *Export Screenshot* (Hotkey: Ctrl-Alt-X). CT Viewer 2 will take a screenshot of the workspace. A *Save As* dialog will appear for you to enter a name and choose a location and file type to save the resulting image file (Figure 5.6).

## 5.7 Configuring Ethernet Settings




Figure 5.7 Ethernet options.

Click on File then Ethernet Configuration (Hotkey: Ctrl-E). This will display an Ethernet configuration dialog box (Figure 5.7).

- 1. The IP addresses shown in Figure 5.7 are only an example. IP addresses listed in the dialog box are for the machine running CT Viewer 2. You will need to enter one of the listed IP addresses into the CT100B configuration to connect a CT100B to CT Viewer 2 using Ethernet. For more information on connecting using Ethernet, see Section 3.2.
- 2. The port number displayed in the dialog box is the one that CT Viewer 2 will listen to for incoming connections.

Usually you do not need to change these settings. If you do, enter the port number to use, select whether to listen on the port, and press OK to accept the new settings.

## 5.8 Loading Traces From Files

#### 5.8.1 Set Default Trace Folder

Set Default Trace Folder in the File menu opens a window for selecting the default folder for loading and saving traces. Each time the Open Trace command is used, it will begin in the default folder.

Imported traces will be saved to the default folder.

## 5.8.2 Open Trace

 $Open\ Trace$  is used to load traces that have been transferred from a CT100B and stored as ".mohr" files on your PC.




Figure 5.8 The Open Trace (Hotkey: Ctrl-O) option can be found under the File menu.

- Click on File then Open Trace (Hotkey: Ctrl-O). See Figure 5.8. Open Trace will always start in the folder selected using Set Default Trace Folder.
- 2. Select the file to load.
- 3. Click on *Open*. The trace contained in the file will be loaded onto the workspace.

## 5.8.3 Envelope Plots

Envelope plots that have been saved as screenshots on the CT100B can be transferred to and viewed on CT Viewer 2.

#### 5.8.3.1 Copy Envelope Plots

Connect the CT100B to CT Viewer 2 via USB or Ethernet. For more information on connecting CT Viewer 2 to the CT100B, see Section 3.1 and Section 3.2.

 Click on File then Copy Envelope from Tester. A dialog box will appear. See Figure 5.9.



Figure 5.9 Dialog box for copying envelope plot screenshots.

- 2. Select the envelope plot to copy.




Figure 5.10 An envelope has been successfully copied to CT Viewer 2.

- Click Copy. When the envelope plot has been copied to the default trace folder for CT Viewer 2, it will be displayed in the bottom part of the dialog box. See Figure 5.10.
- 4. When finished with copying envelope plots, click Close.

#### 5.8.3.2 Open Envelope Plots

Envelope plot screenshots can be viewed in CT Viewer 2 once they have been copied to the default trace folder.

- 1. Go to File then Open Envelope.




Figure 5.11 Viewing an envelope plot screenshot.

- 2. A list of envelope plot screenshots appears. Select the envelope plot to view and click *Open*. The envelope plot will appear on-screen. See Figure 5.11.

When finished with viewing the envelope plot screenshot, select Close.

## 5.8.4 Import .ZTP File to Trace Folder

Import .ZTP File to Folder is used to import the traces stored in a ZTP file to the default folder as set by Set Default Trace Folder.

ZTP files are an older format that can store multiple traces in a single file. When ZTP files are imported into CT Viewer 2, they are converted to .mohr files.

## 5.8.5 Open Other Files

Use *Open Other Files* to open other file formats, e.g., files from older CT100s or from EFPs (another instrument manufactured by MOHR). Supported file formats include CSV, XML, CTV, and CTM.

## 5.9 Saving Traces to a File

## 5.9.1 Save a Copy or Export

- 1. Import the desired traces onto the workspace.
- 2. Select a trace.
- 3. Click on File then Save a Copy or Export and enter a name.
- 4. Select a file format to save to. Supported file formats: mohr, CSV, XML.
- 5. Click on Save.

#### 5.9.2 Save Trace to Database

See Section 8 for information on configuring a database.

- Import the desired traces onto the workspace.
- 2. Select a trace.
- 3. Click on File then Save Trace To Database.

# 5.10 Renaming Traces

CT Viewer 2 offers two methods for renaming traces. The first covers changing the name of traces stored within ".mohr" files, and the second method addresses traces stored on a SQL database. Changing the trace name also changes the actual filename of the trace.

For the purpose of Section 5.10.2, it is assumed that a database connection has already been set up for CT Viewer 2.

#### 5.10.1 Rename a Trace Stored in a .mohr File

- 1. Open a ".mohr" trace file.
- Click on the name of the trace in the information bar (Figure 5.12) at the bottom of CT Viewer 2. A dialog will appear upon clicking on the trace name (Figure 5.13).



Figure 5.12 The trace name box will change color from pink to red when moused over.



Figure 5.13 The dialog box will appear once the user clicks on the Trace name box.

3. Enter the new name for the trace into the dialog and click the SET button. You will be given a chance to confirm or reject the name change and overwrite the saved trace. If you click Yes, the new trace name will be displayed (Figure 5.14) and the filename for the trace will be changed to the new name.



Figure 5.14 The new name of the trace after being changed in the dialog.

#### 5.10.2 Rename a Trace Stored in a Database

1. Open the database containing the desired trace by clicking the Open button in the bottom right of CT Viewer 2 (Figure 5.15) or by selecting  $File \rightarrow Open\ Current\ Database$  from the menu bar. See  $Working\ With\ SQL$  for instructions on setting up a connection to an SQL database.



Figure 5.15 The Open button at the bottom right of CT Viewer 2.




Figure 5.16 Database with a trace selected for editing.

2. Select the trace that you wish to change the name of (Figure 5.16).




Figure 5.17 Clicking on the name of the trace will enable editing.

3. Click on the name of the trace you want to edit under the *Trace Label* column (Figure 5.17).




Figure 5.18 Press enter to immediately save the name to the database.

4. Enter a new name for the trace and press the Enter key (Figure 5.18).

5. The name of the trace has now been updated within the database.

If the trace is already loaded on-screen, it will need to be reloaded before the name change will take effect on-screen.

# 5.11 Changing How CT Viewer 2 Displays Traces (View Menu)

The *View* menu (Hotkey: Alt-V) contains a host of options to manipulate the way CT Viewer 2 displays traces.

## 5.11.1 Changing the Horizontal Unit of Measurement





Figure 5.19 The Horizontal Units option is found under the View menu.

To change the horizontal unit of measurement that CT Viewer 2 uses, click on *View* then *Horizontal Units*. Select the desired unit. See Figure 5.19.

After selecting a new unit type, CT Viewer 2 will recalculate its ruler, and all measurement will be done in that unit.

#### 5.11.1.1 Nanoseconds Ruler

CT Viewer 2 can display ruler measurements in nanoseconds. Go to *View*, then *Horizontal Units*, then *Show NS in Ruler*. The ruler will then show nanoseconds as its primary measurement, though the cursors will be labeled on the ruler with the chosen horizontal unit. See Figure 5.20.



**Figure 5.20** The horizontal ruler with measurements in nanoseconds. The cursors are labeled on the ruler with the chosen horizontal unit, which in this case is feet.

### 5.11.2 Changing the Vertical Unit of Measurement

To change the vertical unit of measurement that CT Viewer 2 uses, click on *View* then *Vertical Units*. Select the desired unit.

After selecting a new unit type, CT Viewer 2 will recalculate its ruler, and all measurement will be done in that unit.

## 5.11.3 Changing the Rendering Mode

The Rendering Mode option can be found under the  $\mathit{View} \to \mathit{Options}$  menu (Figure 5.21).



**Figure 5.21** The Rendering Mode option.

After a new rendering mode is selected, CT Viewer 2 will use that mode to draw the on-screen traces.




Figure 5.22 Line rendering mode.

To change the rendering mode that CT Viewer 2 uses, click on *View* then *Options*. Select the rendering mode you desire. You can choose between rendering with points or lines. See Figure 5.22 and Figure 5.23 for examples of each rendering mode.

# 5.11.4 Displaying Extra Grid Lines




Figure 5.24 Workspace with and without extra grid lines.

To instruct CT Viewer 2 to draw extra grid lines, click on  $\it View$  then  $\it Extra~Grid~Lines$ . See Figure 5.24.

## 5.11.5 Standard Deviation

To display the standard deviation of the selected trace in the *Information Box/Cursor Measurements* window at the bottom right, click on *View* then *Standard Deviation* (Figure 5.25).

#### 5.11.6 VSWR

To display the voltage standing wave ratio (VSWR) in the Information Box/Cursor Measurements window at the bottom right, click on View then VSWR (Figure 5.25).

## 5.11.7 Temperature Display

To display the temperature for the selected trace on-screen, click on *View* then *Temperature Display*. The temperature will be displayed in a small box near the bottom of the screen (Figure 5.26).



Figure 5.26 The temperature display for a selected trace.

#### 5.11.8 Vertical Zoom at Cursor Location

To keep the Y value at the cursor fixed when increasing or decreasing the vertical scale (zooming in and out), click on *View* then *Vert Zoom at Cursor*.

# 5.11.9 Trace Label Options (Alignment and Visibility)




Figure 5.27 The Trace Labels options can be found under the View menu.

To change the trace label options that CT Viewer 2 uses, click on  $\it View$  then  $\it Trace\ Labels$  (Figure 5.27).

With these options, a user can choose how to display the trace name associated with each trace on the workspace. The default display is set to auto align with traces, but the user can choose a new default or choose to have the trace names on the current screen displayed at the top right or top left. Trace names can also be hidden or shown again using this menu, and the display font and font size for the trace labels can also be changed.

#### 5.12 Annotations

Individual points or a range of points on a trace can be annotated on the CT100B or in CT Viewer 2. Annotations that have been saved on a trace on the CT100B can be viewed, modified, or deleted in CT Viewer 2. New annotations can also be created in CT Viewer 2.

## 5.12.1 Annotating Traces

To annotate an individual point on a trace, move the active cursor to that point. If a range of points on a trace needs to be annotated, move the active and inactive cursors to the starting and ending points of the range. To create an annotation:

- 1. Go to Tools then Add New Annotation.




Figure 5.28 The annotation drop-down menu.

- Select either Point Annotation or Range Annotation from the drop-down menu. See Figure 5.28.




Figure 5.29 Annotations and the annotation information box.

A point annotation will be indicated by a single triangle on the trace. A range annotation will have a triangle at each end of the range with a line connecting the two triangles. Click on a triangle to view annotation information. See Figure 5.29. The initial annotation indicates the points in nanoseconds, but this information can be changed. See Section 5.12.2.

Go to File then Save to save the trace with annotations.

## 5.12.2 Modifying and Deleting Annotations

You can modify or delete annotations created on the CT100B or in CT Viewer 2. Click on an annotation triangle to bring up the annotation information box.

Prior to making any changes, make sure the *Allow Changes* box has been selected. See Figure 5.30.



Figure 5.30 Select Allow Changes in the annotation information box before modifying an annotation.

Replace the current annotation text with the new annotation. Click *Set* to change the annotation. To delete an annotation, select the annotation triangle and then click *Delete* in the annotation information box. Go to *File* then *Save* to save the trace after modifying or deleting annotations.

#### 5.13 Math




Figure 5.31 The Math menu.

The *Math* menu contains a list of special functions that perform calculations on traces. CT Viewer 2 ships with a number of standard functions. The standard set of plugins is shown in Figure 5.31 and described in Table 5.1.

There is a programmer's API available for users to create additional plugins. Contact MOHR for more information.

The traces displayed by CT Viewer 2 can be divided into two broad categories: time-domain traces and frequency-domain traces.

Time-domain traces include saved TDR traces. The horizontal axis represents time and distance with units of nanoseconds and feet or meters.

Frequency-domain traces include FFT traces, S-Parameter  $(S_{11})$  traces, and phase traces. In CT Viewer 2, these are always transformations from one or more time-domain traces. The horizontal axis represents frequency with units of hertz or megahertz.

The two classes of traces have separate pairs of cursors. When a frequency-domain trace is selected, CT Viewer 2 will switch from the two time-domain cursors to two frequency-domain cursors.

Most *Math* menu options, such as smooth, will produce a new trace that is in the same domain as the parent traces. For example, the smooth transformation of an FFT trace is in the frequency domain. Some *Math* menu options only work with certain domains. Average, difference, and derivative traces only give accurate results for time-domain traces. Phase and complex division can only be used on frequency-domain traces. If you want to find the difference between two FFT traces, use complex division instead of difference.

The following math functions assume that the operator has loaded a few traces on to the CT Viewer 2 workspace.




Figure 5.32 The primary selected trace (red), secondary selected trace (teal), and unselected trace (black).

Use Figure 5.32 as the base figure for comparison in the following sections.

## **5.13.1** Average

- 1. Select the traces of interest.
- 2. Click on Math, then Average.




Figure 5.33 Taking the average of the two teal traces. The new average trace is shown in red.

- 3. A new trace will be created that is the average of the selected traces (Figure 5.33).

#### 5.13.2 Difference

- 1. Select two traces of interest.
- 2. Click on Math, then Difference.




Figure 5.34 Taking the difference of the primary (red) and secondary (teal) selected traces. The difference is shown in blue.

- 3. A new trace will be created that is the difference of the selected traces (Figure 5.34).

**Note:** The vertical scale of the new trace is not necessarily the same as the originals. The green arrows highlight that where the two selected traces intersect, the difference is zero.

#### 5.13.3 FFT




Figure 5.35 Options for FFT plugin.

Select the trace of interest. Click on *Math*, then *FFT*. Enter your choice for window size and choose from the standard windowing functions in the *Options* dialog (Figure 5.35). Hann is a reasonable default windowing function for almost all situations.




Figure 5.36 Getting the FFT of a cable trace. The FFT is shown in red.

A new trace will be created that is the Fast Fourier Transform of the selected trace (Figure 5.36).

#### 5.13.4 Phase

This module will generate a phase trace based on a frequency-domain trace. Phase traces can be created for FFT, Complex Division, and S-Parameter traces. The result is the phase-angle of the complex value of the trace at each frequency.

- 1. Select a frequency-domain trace.
- 2. Click on the Math menu item, and select Phase.

## 5.13.5 Complex Division

This module will generate the negative complex division between two FFT traces. Use the following steps to do this.

- 1. Select two frequency-domain traces with the same resolution.
- 2. Click on the Math menu item, and select Complex Division.




Figure 5.37 Getting the Complex Division of two FFT traces. The Complex Division is shown in red.

- 3. A new trace will be generated that is the negative complex division between the primary trace and the secondary trace (Figure 5.37).

#### 5.13.6 S-Parameter

The S-Parameter tool will generate a new  $S_{11}$  return loss plot for a specified measured trace. To use this tool, please use the following steps.

- 1. Select four time-domain traces. Three of the traces will be used as calibration traces taken with a short, open, and 50  $\Omega$  terminator. The fourth trace will be the measured trace to generate an S<sub>11</sub> return loss plot.
- 2. Click on the Math menu item and select SParameter.
- 3. In the pop-up window, identify the short, open, load, and measured trace (Figure 5.38).




Figure  $5.38 S_{11}$  Trace Identification window with traces selected for short, open, load, and measured.

 Click OK. A new trace will be created that is the S<sub>11</sub> return loss plot of the measured trace.

## 5.13.7 First Derivative (Slope)

Create a new trace that is the calculated slope at each point of the selected trace. The trace will often amplify subtle features of the original trace.




Figure 5.39 Slope of a cable highlighting some defects.

For example, in Figure 5.39, we can easily see the defects in a 1000' cable. Inspection of the physical cable revealed that these perturbations were actually connections in the cable where the manufacturer had connected shorter pieces to make up the 1000' length.

The cursors are on two spikes located at about 156 ft. and 208 ft.

#### 5.13.8 Smooth

Create a new trace that has a smoothing filter applied to the selected trace. The trace is smoothed by averaging neighboring points. Choosing Smooth will bring up a smoothing options dialog box (Figure 5.40).



Figure 5.40 Smoothing options.

There are two things you can adjust in this dialog box:

- 1. The number of points (the window size) to use in each averaging operation.
- The algorithm to use. Choose from Radial Filter or Binomial. Both of these are weighted filters where the center points in the averaging window count more than the ones at the edge. Radial Filter is the preferred algorithm.

# 6 Remote Control

# 6.1 Setting up Remote Control

## 6.1.1 Connecting the CT100B




Figure 6.1 Remote Control menu.

Connect the CT100B to CT Viewer 2 via Ethernet. For more information on connecting using Ethernet, see Section 3.2. Remote Control does not work over a USB connection. Once a successful connection has been made, click on Remote Control then Enable Remote Control (Figure 6.1).




Figure 6.2 The CT100B/CT Viewer 2 connection has been established.

CT Viewer 2 will negotiate a live stream with the CT100B. Once a successful handshake has been made, a live trace will appear on the workspace (Figure 6.2).

The live trace matches the trace the CT100B is measuring. An operator can use CT Viewer 2 to manipulate this live trace like any other trace. Any action done to the live trace will also be done in the CT100B. The live trace will update itself on-screen at a maximum rate of 24 frames per second.

#### 6.1.2 Assistant Mode

After a valid CT100B/CT Viewer 2 connection has been made and a live trace is on the workspace, the CT100B is in a screensaver mode. Assistant Mode allows the trace to be displayed on the CT100B screen simultaneously with the trace in CT Viewer 2. Controls on the CT100B (such as Vp adjustments and horizontal and vertical scale and position changes) as well as the controls in the CT Viewer 2 program can be used to manipulate the trace. Any action done on the live trace in CT Viewer 2 is reciprocated over to the CT100B. This way the operator on each end will be viewing the same region of the trace. This mode can be useful for providing remote support to a CT100B user.

Turning on Assistant Mode will slow the maximum frame rate that the CT100B can transfer to the CT Viewer 2 software. To turn Assistant Mode off, simply uncheck it on the Remote Control menu.

### 6.1.3 Disconnecting Remote Control

To disconnect Remote Control, click on *Remote Control* then *RC Disconnect*. Remote Control will disengage, leaving the live trace on the CT100B updated to reflect any actions done to it in CT Viewer 2.

**Note:** After disconnecting Remote Control, CT Viewer 2 and the CT100B are still connected.

#### 6.2 Overview

## 6.2.1 Adjusting Frame Rate




Figure 6.3 The Adjust Frame Rate option under the Remote Control menu.

To change the frame rate in which data from the CT100B is sent, click on Remote Control then Adjust Frame Rate (Figure 6.3).

Generally, an operator would want a faster frame rate when recording a time slice. Normally the frame rate should be slower, skipping a larger number of frames between transmissions.

#### 6.2.2 Live Trace Smooth Mode

CT Viewer 2 can smooth (average) the incoming frame data to a specified sample range, much like how smoothing can be set from 1x to 1024x on the CT100B. For example, choosing a smoothing mode of 64x will instruct CT Viewer 2 to average the past 63 frames with the current frame.




Figure 6.4 Changing the smooth mode with the Remote Control menu.

By default, the smooth mode is set to 1x. To change the smooth mode, click on *Remote Control* then *Live Trace Smooth Mode* and select the desired sample size (Figure 6.4). **Note:** Changing the *Live Trace Smooth Mode* sample size is not reflected on the CT100B.

Higher frame rates will allow a faster smoothing calculation. See Section 6.2.1 for help on changing the frame rate.

## 6.2.3 Recording a Movie (Time Slice)

Select Record To Movie File from the Remote Control menu. This will bring up a Save As dialog box. Give the movie file a name. It will automatically be set to save in the default folder as chosen by Set Default Trace Folder in the File menu, though you can choose a different location to save the movie file to. (See Section 5.8.1 for more information on the default trace folder.)




Figure 6.5 Record To Movie File and Stop options under the Remote Control menu

Once you click Save, recording begins. When you are finished, select the Stop option under Remote Control (Figure 6.5).




Figure 6.6 CT Viewer 2 is recording data from the CT100B.

While recording is active, it is indicated by the RECORDING label next to the live trace (Figure 6.6).




Figure 6.7 Selecting a movie trace to load into the workspace.




Figure 6.8 The movie trace has just been loaded.

After you have completed recording and selected Stop, you can load the movie trace into the workspace. Use the  $File \rightarrow Open\ Other\ Files$  menu and select the filename that you created (Figure 6.7 and Figure 6.8).

### 6.2.4 Navigating a Movie (Time Slice)

Navigating a movie (time slice) is done by instructing CT Viewer 2 to render the specific frame that you are interested in.

The trace label of a movie file displays what frame of the movie you're currently on and how many frames are in the movie (e.g., 1/1168), as well as a time stamp for the frame in seconds.




Figure 6.9 Movie sub-menu.

You need to have the movie trace selected in order to use the actions under the *Movie* option in the *Tools* menu (Figure 6.9).

#### 6.2.4.1 Next Frame

- 1. Select the trace with the mouse. This will turn the trace red.
- 2. Press the period key on the keyboard.
- 3. CT Viewer 2 will update the trace to reflect the next frame of the trace.

#### 6.2.4.2 Previous Frame

- 1. Select the trace with the mouse. This will turn the trace red.
- 2. Press the comma key on the keyboard.
- CT Viewer 2 will update the trace to reflect the previous frame of the trace.

#### 6.2.4.3 Goto Frame #

- 1. Select the trace with the mouse. This will turn the trace red.
- 2. Go to  $Tools \rightarrow Movie \rightarrow Goto Frame \#$ .

- 3. Enter a frame number in the dialog box and click OK.
- 4. CT Viewer 2 will update the trace to reflect the chosen frame of the trace.

# 7 Keyboard and Mouse Help

Pressing the spacebar in CT Viewer 2 will bring up an illustration of keyboard and mouse shortcuts (Figure 7.1). Pressing the spacebar again will remove the illustration from the screen.



Figure 7.1 Pressing the spacebar brings up keyboard and mouse shortcuts.

# 8 Working With SQL

Working with SQL is optional and only recommended if the user has previously used CT Viewer 1 and has databases from previous use that they would still like to use in CT Viewer 2.

## 8.1 Configuring the Database




Figure 8.1 The Select a Connection button at bottom of the display window.

To configure a database for CT Viewer 2 to use, click on the *Select a Connection* button at the bottom of the display window (Figure 8.1).




Figure 8.2 The Add a Server dialog box.

Choose Add a New Server from the menu. This brings up a dialog box (Figure 8.2).

If you have an SQL Express installation on your PC, you can just click *Test Connection*. If you don't have a local installation, enter the server name or IP information for your network SQL server and then click *Test Connection*. If *Test Connection* succeeds, a dialog will ask if you want to add the server to your list. Choose OK and close the *Add a Server* dialog. Now click again on the *Select a Connection* menu and choose the connection that you just created (Figure 8.3).



Figure 8.3 Choose your SQL connection.

Now that you have chosen an SQL server connection, the *Select a Database* button will populate with the list of databases available from that server. Choose the database that you wish to use or select the *Create Empty Database* option (Figure 8.4).



Figure 8.4 Choose a database from the SQL server.




Figure 8.5 File menu with database options.

Now that you have a database selected, there are two database commands in the *File* menu available to you, *Open Current Database* and *Save Trace to Database* (Figure 8.5).

# 8.2 Loading Traces From a Database to the Workspace

Click on File then Open Current Database (Hotkey: Ctrl-B).

Clicking on this item will open a database window displaying a list of traces contained in the current database.




Figure 8.6 An example of a database overview.

Figure 8.6 shows the result of the *Open Current Database* command. Select a trace by clicking on rows in the table. Use Shift-click or Ctrl-click to select additional traces. The buttons across the top of the window are used to perform different actions on the selected trace(s). These are described in Table 8.1.

View Trace	Load the selected traces onto the workspace.
Refresh	Reload the database to see if any new traces have been added since the last refresh.

Exit the database overview by pressing the X button on the top right corner of the window.

# 8.3 Saving Traces in a Database

Traces that are displayed in CT Viewer 2 can be saved as .mohr files or can be saved in a database. Use  $File \rightarrow Save\ Trace\ to\ Database$ , and the currently selected trace is added to your database. Click the  $Refresh\ button$  to see that the trace has been added to the collection. See Figure 8.7.
